For nearly 14 years, John F. Garofalo has been a steady and trusted presence at Akron Community Foundation. Previously serving as Vice President of Community Investment, his name became synonymous with grantmaking strategy, nonprofit partnerships and a thoughtful, community-centered approach to philanthropy.

Now, he steps into a new role – one that builds on his experience and relationships – as the foundation's new President and Chief Executive Officer. It's a natural transition that has been met with enthusiasm from board members, staff, donors, grantees and community leaders alike – because while the title may be new, the commitment and care John brings to his work are anything but.

#### A DEEP COMMITMENT TO COMMUNITY

In his previous role, John oversaw the distribution of more than \$125 million in grants to nonprofits across Greater Akron and beyond. But to him, it was never just about the dollars. It was about relationships. His vision of philanthropy is deeply collaborative: one that brings donors, nonprofits and the community together to solve challenges and embrace opportunities.

"I've always seen this work as a partnership," John said. "Whether we're funding early childhood education or helping grassroots organizations grow, the heart of it is listening and lifting up the people doing the work."

Long before arriving at Akron Community Foundation, John had already built an impressive career dedicated to improving lives. He held leadership and development roles at organizations like UH Rainbow Babies & Children's Hospital, United Way of Greater Cleveland, United Way of Greater Stark County, and the American Red Cross.

Throughout those roles, John honed expertise in nonprofit management, strategic planning, fundraising, grantmaking and community engagement. He also earned and has maintained his Certified Fund Raising Executive (CFRE)

credential since 2004, demonstrating his longstanding commitment to excellence and ethics in the field.

His education also reflects that same commitment: John holds both a Bachelor of Science in Community Health Education and a Master of Education in Community Health Management and Administration from Kent State University.

While John's résumé is impressive, what truly sets him apart is his love for Akron. A resident of Northwest Akron, he not only works to improve the community professionally but also gives back personally. He currently serves on the boards of ArtsNow, Akron Roundtable, the Downtown Akron Development Corporation, and the county-appointed Social Services Advisory Board. He is also a member of the Leadership Akron board and will become chair of the organization next summer.

#### LOOKING AHEAD

As he begins this new chapter, John is excited to continue building the legacy of the foundation while preparing it for the future.

He inherits a foundation that has more than tripled its assets and funds under management over the past two decades, while more than doubling its total grantmaking to nearly \$260 million. Yet John is the first to say this isn't about one person; it's about community.

"I'm incredibly honored to lead Akron Community Foundation, but I don't do this work alone," he said. "It's done alongside a phenomenal staff, dedicated board, generous donors and visionary nonprofit leaders. Together, we can keep moving Akron forward."

Because, while Akron Community Foundation now has a new CEO, it still has the same commitment: to connect people, passion and purpose for good. And with John at the helm, that future is in very capable hands.

Greenleaf Family Center





Mission: We strengthen families in our community through counseling, education and support.

For more than 20 years, Greenleaf Family Center's PEERS (Parent Education, Empowerment, Resources and Support) program has empowered families of children with complex needs by training parents to navigate multiple systems of care and become lifelong advocates for their children. Backed by longtime support from Akron Community Foundation, PEERS has helped countless families maximize their children's chances for success through education, guidance and emotional support.

Now, thanks in part to a \$79,000 proactive grant from Akron Community Foundation, Greenleaf is building on this legacy by launching the PEERS Center for Family Engagement. This bold new initiative will amplify parent and caregiver voices, particularly those raising children with mental health challenges, and work with organizations across Summit County to adopt more family-driven care practices and reduce stigma. The Center model will expand Greenleaf's work from individual support to systemic change, offering group advocacy training, peer facilitation, and leadership development to help families move from crisis to influence.

Founded in 1912 by civic leaders including F.A. Seiberling, Harvey Firestone and Bert Polsky, Greenleaf Family Center serves individuals and families across five counties, including Summit, with a wide range of services, including counseling, education and behavioral health support. From individual, family and group counseling to parenting programs and youth services, Greenleaf helps people manage life's emotional challenges with compassion and skill.

"I'm particularly passionate about expanding our ability to help people navigate emotional systems, whether as part of a family, workplace or community," said Greenleaf CEO Jill Oldham. "When individuals come to us, they're often focused on immediate life challenges, which can lead to anxiety, conflict, communication breakdown or other symptoms. What excites me is the potential to not only help them with these immediate needs, but to also help them recognize how their reactions and behaviors are interconnected with those around them."

#### **FAREWELL TO AKRON COMMUNITY FOUNDATION**

What a wonderful ride on this farewell tour I'm touched by the tributes and praise What started out as a year's long search by our board Has been whittled down to just days

Remember, I'm someone who's not from here With little history or much knowledge of this place Who humbly accepted this role as a leader So grateful for the community's embrace

At the heart of our work are the people The best I've ever met, this I'm sure Who simply care about giving and granting Always knowing there's a need to do more

With a spirit of caring so strong and inspiring Such selfless desire to give back Lifting lives of families and strangers in town Reaching out, meeting needs, filling gaps

Some might say it's my calling To listen, to learn, and to lead Surrounded by a team: a board and staff Lifted by such commitment indeed

My career took me to three different states Raising our family as we made a new home Lessons learned all along the way From mentors and colleagues I've known

Thank you seems terribly inadequate To capture this gratitude I feel To have felt the embrace of this special place I've gotten the best end of the deal

Keep in mind we're all temporary stewards Who help guide, inspire and teach We strive to improve the human condition That just might be within reach

Think for a moment about this work that we do How vitally important it must be Good intentions have never really moved our world Investing in each other is key

We raise money, award grants, celebrate leaders Millions raised and awarded, it's true People give to people, not causes, today Is something that I always knew

With heartfelt gratitude I step away from my calling Blessed by these moments to serve Thank you wholeheartedly for trusting and believing And I hope that these rhymes touch a nerve

Enduring philanthropy is at the heart of our mission Place-based, right here through the ages Our history is written, we see our work mattered Captured as we glance at the pages

I've told many that I'm certain I'll miss it To have led such a remarkable team We planned our work and we worked our plan We dared to think big and just dream

I'll keep watching and celebrating your progress Achievements and challenges will come Our community will be better and enriched by this work Congrats, in advance, and well done!





Amid a nationwide epidemic, Summit County remains deeply impacted by one of the most pressing public health and safety challenges of our time. As of June 30, 2025, the county has recorded 487 suspected overdoses this year – an average of more than two each day.

Fifty-two of them have been fatal.

The numbers are tragic, but they're not just numbers. They represent lives lost, families shattered, and communities reeling from a crisis fueled by prescription opioids and compounded by newer, more complex threats.

Increasingly, these overdoses involve multiple substances – fentanyl mixed with meth, alcohol laced with cocaine – combinations that make treatment increasingly more complicated. These polysubstance overdoses have

become a leading concern for public health professionals. They often require specialized "dual diagnosis" care – treatment that addresses both substance use and underlying mental health conditions, according to Donna Skoda, recently retired health commissioner for Summit County.

Add to this the stigma that addiction carries: Many people still view addiction as a moral failing rather than a diagnosable disease. There's also a misconception that treatment and recovery are "one size fits all."

Yet even in the face of these grim realities, there is hope. And it's coming in the form of one of the largest single investments in Summit County's public health and safety history.

#### A GROUNDBREAKING SETTLEMENT

When Summit County Executive Ilene Shapiro joined a federal lawsuit against prescription drug manufacturers, she never expected

the county to receive a penny. Not only was Summit County awarded a settlement, but it became a bellwether for legal cases across the country. It placed the county at the forefront of a systemic remediation to the devastating role prescription narcotics have played in a national health crisis.

The initial federal court settlement led to Summit and Cuyahoga counties reaching agreements in principle with drugmaker Teva Pharmaceuticals and drug distributors AmerisourceBergen, Cardinal Health and McKesson. Per the proposed settlement agreements, Teva was ordered to pay \$20 million in cash and provide \$25 million worth of addiction treatment drugs to the two counties, while AmerisourceBergen, Cardinal Health and McKesson were required to pay a combined \$215 million in cash. Summit and Cuyahoga counties split the settlements at 38% and 62%, respectively.

Thanks to that initial settlement, a \$45 million investment will be used to establish the Summit Health and Safety Innovation Fund at Akron Community Foundation. The fund will operate as a separate, tax-exempt, charitable organization of Akron Community Foundation known as a supporting organization.

"When we first received the settlement funds, I had three goals," Shapiro said. "First, to get money out into the community to stop overdoses and enhance pathways to treatment and recovery. Second, to purchase a software platform that would allow providers and other stakeholders to better coordinate care for those with substance use disorder and reduce barriers to accessing care. Today, the Unite Us platform is free to any community organization in Summit County. Finally, I wanted to identify a mechanism that would allow a portion of the funds to be available in

perpetuity to fund innovative programming that could address the health and safety issues of today, but also whatever challenges await us in the future."

#### A UNIQUE ARRANGEMENT


According to the IRS, a supporting organization's classification as a nonprofit is unique in that it is a distinct legal entity, but it relies on its relationship with a public charity, often a community foundation, hospital or university. A local example of a supporting organization is the Barberton Community Foundation, which was established using proceeds from the sale of the former Barberton Citizens Hospital and is a supporting organization of the City of Barberton and the Barberton City School District.

The creation of a supporting organization will enable the Summit Health and Safety Innovation Fund to have maximum community impact: The fund will be permanently endowed

and invested according to an investment policy that may mirror Akron Community Foundation's, but it will exist as its own Ohio nonprofit corporation. The fund will also have its own governing board of directors charged with management of the organization and grantmaking, among other responsibilities.

"In establishing the supporting organization, we expect three outcomes," Shapiro said. "First, it will support innovative approaches to health and safety by providing startup funding for good ideas that need legs to get off the ground. Second, it will act as a convener to attract sustained funding for proven ideas. Finally, it will have the flexibility to respond to whatever health and safety issues emerge in Summit County. Today it is opioids; tomorrow it could be something completely different."



The decision to partner with Akron Community Foundation and create this organizational structure was made after thorough research.

"After investigating our options, we identified the supporting organization structure," Shapiro said. "It was a no-brainer to ask Akron Community Foundation to host it. Having served as a board member and been a witness to the impact of this organization, I knew the community foundation was well-suited to help us make it a reality."

"Akron Community Foundation's role has always been to connect resources with community needs," said John T. Petures Jr., former president and CEO of Akron Community Foundation. "By housing this fund, we're helping to ensure that settlement dollars stay local, support innovation, and adapt to the evolving health and safety challenges facing Summit County for generations to come."

The fund is more than a financial vehicle - it's part of a larger ecosystem of support in Summit County, which is home to a wide network of community-based recovery organizations.

"Akron is the birthplace of Alcoholics Anonymous and is very fortunate to have a variety of self-help groups, anonymous support groups, and communitybased organizations," Skoda said. "In addition, there is a web of peer support, grassroots and nonprofit agencies focused on both substance use and mental health support. Peer supporters are people with lived experience of substance use or mental health concerns who have

found their own recovery and now use their experience to help others."

Peers, she said, can get specialized education and training to be licensed through the Ohio Department of Mental Health and Addiction Services, offering a vital avenue for people in recovery to connect in ways they can't with clinicians and doctors.

In addition, Skoda said, "Many grassroots and nonprofit organizations in Summit County also provide support not just for those struggling, but for their children and families, offering opportunities and resources for healing that spread far beyond the individual."

#### **LEGAL WIN SPARKS COMMUNITY INVESTMENTS**

This isn't the county's first collaboration with Akron Community Foundation Following the settlement, Shapiro and a group of stakeholders, including

Akron Mayor Shammas Malik and Summit County Public Health, helped assemble the Opiate Abatement Advisory Council, which provides oversight to ensure funding from the settlement goes to Summit County programs that help to abate the opioid epidemic by addressing four priority areas: Harm Reduction, System Coordination, Evidence-Based Prevention and

In 2021, the OAAC established the Summit County Opioid Healing Fund at Akron Community Foundation, which has distributed more than \$1.2 million in grants – up to \$25,000 each – for peer support services, recovery events and community education.

In total, the OAAC has deployed nearly \$16 million in opioid settlement funds, but the supporting organization takes those efforts a step further -

> it's a permanent, community-led strategy for the long haul.

The Summit Health and Safety Innovation Fund was approved by Summit County Council in December 2024 and is estimated to be fully established and funded with the initial \$45 million investment at Akron Community Foundation by the end of 2025. In addition, the county approved the creation of a separate \$5 million fund at the community foundation to specifically support programs that address the significant health and safety issues faced by minority and disadvantaged residents in Summit County.

Once in operation, the supporting organization will likely generate

more than \$1 million in funding for nonprofits in the community each year resources that weren't available before.

"This isn't just about responding to a crisis," Petures said. "It's about creating the kind of community where prevention is possible, treatment is accessible, and innovation thrives."

A silver lining to a heinous epidemic, it's a chance to heal some of the damage done in neighborhoods across Summit County.

## SUPPORTING STUDENTS WHO BREAK THE MOLD

Karen Towne works full time as a faculty member at a small private university in Northeast Ohio, where she enjoys mentoring students and helping them find their path in the nursing profession. A married mother of two, Karen is also a member of the Sigma Theta Tau International Honor Society of Nursing and the Honor Society of Phi Kappa Phi. In addition to these accomplishments, Karen recently earned a Ph.D. in nursing from the University of Kansas School of Nursing.

Like Karen, many nursing students who pursue advanced degrees do not fit the typical description of a college student.

During the spring 2025 semester, Karen completed her dissertation research on the relationship between disaster-related prenatal stress and pregnancy outcomes. For Karen, this research was more than a graduation requirement – it was a critical part of her identity as a nurse advocate.

"I became an advocate because, as a young cancer survivor, I felt my highest and best good was to work on preventing disease from beginning in the first place. That is what drew me to the field of public health. Research provides much-needed credible evidence to policymakers, which is why engaging in public health nursing research is my next commitment to advocacy," Karen said.

Scholarships like the Summit, Portage, Stark, Carroll Nursing Scholarship (SPSCNS) Fund at Akron Community Foundation have allowed Karen to fully engage in her research without worrying about financial constraints. In her application, Karen wrote: "Having the ability to focus on what one of my professors calls the 'deep work' of research is a luxury that is difficult to achieve when working full time as a faculty member and taking care of my young children. To be a scholarship recipient would change my life tremendously, alleviating the financial stress of this incredible goal, which I otherwise have the will and ability to achieve."

Karen has a clear vision for her future as a Ph.D.-prepared nurse. She hopes to research major public health issues – like disaster response, environmental health and climate change – and share her findings to help drive meaningful change. She plans to work with health organizations, policymakers and fellow researchers to turn her work into action and improve community health.

Karen is also passionate about mentoring the next generation of nurses and scholars. Thanks to support from this scholarship, she is one step closer to making her vision a reality.  $\P$



## **BUILDING A CHARITABLE LEGACY THROUGH LONG-TERM CARE PLANNING**

> The following are several advanced planning ideas to discuss with vour advisors:

care riders that allow policyholders to split benefits between charity and family long-term care needs. For example, a \$1 million permanent life insurance policy with a \$500,000 long-term care rider can designate surplus benefits to charity upon death.

to combine philanthropy with tax planning goals. A personally owned life insurance policy with a long-term care rider creates an asset that preserves estate assets during a person's lifetime while leaving a leveraged death benefit to complete legacy planning goals.

death benefit to endow the fund upon death.

trust funded with a long-term care policy reduces the taxable estate and involves risk shifting and leverage that many wealthy families already use and turns an irrevocable trust into a more flexible family wealth planning tool. For example, when a claim is paid, the trustee can choose to keep the proceeds in the trust or move tax-free dollars to the insured. The trustowned policy can also be designed with a residual death benefit earmarked for charity. Only contracts with an indemnity payment option can be used with this approach.

The growing interest in long-term care planning, particularly among high-net-worth individuals, reflects a broader shift in how people view aging and caregiving. It's no longer just about managing financial risk; it's about ensuring stability, preserving family relationships, and planning for the unexpected.

As awareness continues to grow, the role of long-term care insurance in comprehensive wealth and family planning is also likely to grow. Coordinating charitable giving with long-term care planning creates a lasting legacy that reflects family values and impacts future generations.

Donors who can work with their advisors to effectively integrate long-term care into traditional financial, estate and charitable planning will be uniquely positioned to achieve peace of mind and build stronger, more sustainable relationships. 🞐

Lessons in Legacy: Retired Teachers Join Shaw Society

When two lifelong Akron residents met with attorney Sheri Peters to talk about their estate plans, they knew they wanted charitable giving to be part of their plan.

As retired educators with no children of their own, the donors care deeply about providing educational opportunities for students. They also have several other charitable interest areas connected to their personal experiences, including disaster recovery and women's causes. In particular, one of the donors grew up with a single mother during a time when there was not a lot of support for single women, so they would like to give back to women facing a similar situation. Growing up in that environment also taught them the importance of budgeting and making a dollar stretch, so it's no surprise that the couple wanted to find a way to make their gift last beyond a one-time impact.

Sheri had a solution for them: creating a charitable fund at Akron Community Foundation through their will. While they discussed the option of leaving gifts through a trust, she explained that a fund at the community foundation would give them the flexibility to change the causes they want to benefit in the future, while also helping their gift endure long after their lifetimes.

This was an A+ idea for the couple, who then met with the foundation's staff to get the process started and become members of the Edwin C. Shaw Society.








#### **GRANT TOTALS BY YEAR**






#### GRANTS BY FUND TYPE
