



## FOR ALLIOS, CELEBRATING MEANS GIVING BACK

Like many Akron natives, Mark Allio's fondest Christmas memories include trips to his grandparents' house. There, he, his parents and his four siblings joined 10 aunts and uncles and many more cousins for an Italian feast in his grandparents' basement. "It was the only place everyone could fit," laughed his wife, Shelly.

Shelly's celebrations took place across town in Cuyahoga Falls. There, she and her three siblings would present every aunt, uncle and cousin with giant bottles of perfume or cases of popcorn – "basically anything you could get at Woolworth's" – which they bought with money scrounged up from coat pockets and couch cushions. "The fun was always in the giving, no matter how small the gift," she said.

#### Food, Friends and Philanthropy

Within those memories are powerful principles that impact all aspects of the Allios' life. Today, the couple enjoys throwing their own celebrations, inviting friends

and strangers alike. This year, they fed and entertained patrons of the Sugar Plum Tour, which benefits Akron Community Foundation's Gay Community Endowment Fund. It's one of many charity benefits they host in their Bath Township home.

"It's an opportunity to meet people we haven't met before. There's no such thing as a stranger; it's just a friend we haven't met," Mark said.

With food being such an integral part of all their celebrations, the couple is making sure more Summit County families can share a holiday meal together. For the third straight year, the Mark and Michele Allio Family Fund at Akron Community Foundation will provide a "ton of turkeys," which the Akron-Canton Regional Foodbank's partner agencies will distribute to needy families across the area. "If we had our way, we would provide them every day," Mark said.

#### **Turning Tragedy into Charity**

Family gatherings were tragically

altered in 2011 when Mark's sister Janet died in a car accident. The couple honored her by starting the Allio Memorial Fund. Today, the fund honors the charitable traditions of both Janet and their father, Thomas, who passed away in October, by supporting the community foundation's grantmaking to causes they believed in.

"Our goal is to alleviate a little bit of the pain other people are going through," Mark said. "It could be clothing, shelter or food." Shelly hopes that, through the fund, future generations of Allios will entertain their tradition of "paying it forward."

#### A TIME-SENSITIVE OPPORTUNITY

With the uncertainty of the looming Fiscal Cliff, you can make a gift now and ensure a charitable deduction for 2012. A Dec. 9 Wall Street Journal article titled "Givers Turn to Donor-Advised Funds" outlined an excellent opportunity for charitable people to capitalize on in the current tax environment. By establishing a donor-advised fund, you can take advantage of current tax law without having to immediately decide which charities you wish to support.

As the article outlines, the steps are simple:

- Estimate how much you plan to give to charity in the next few years
- With a gift of \$5,000 or more, start a donor-advised fund through Akron Community Foundation
- Transfer the assets to your fund by Dec. 31 so all 2012 charitable deductions apply

While grants from your fund cannot be earmarked for existing pledges, you can make periodic grants to the nonprofit organizations you love.

#### ACF EVENT EXPLORES LACK OF DIVERSITY IN TECH JOBS

A lack of minorities in the local technology sector could threaten Northeast Ohio's ability to compete in the regional economy. Akron Community Foundation recently invited local leaders to discuss a report addressing this issue released by Policy Bridge, a Cleveland-based African-American think tank. The "Fusion of Inclusion" report explains that it will be critical to remedy this issue as competition mounts for high-growth technology jobs in the near future.

The technology sector will flourish over the next five to 10 years, but "when we look at who the entrepreneurs are, nowhere do we see minorities in the mix," said Randell McShepard, co-author of the report from Policy Bridge. "There is underperformance of African-American and Latino populations in this field. You can't move forward and leave this subset behind."

There are significant disparities for minorities in employment, entrepreneurship, engagement and education, said Gregory Brown, also from Policy Bridge. With employment, area minorities are less likely to hold management positions. As entrepreneurs, said Brown, minorities face a host of barriers, from disjointed business advice to lack of access to funding.

"The lack of mentors also is a real challenge," Brown said.

In metropolitan regions, a number of minorities live right next to resources they are never able to access, said Johnathan Holifield, vice president of inclusive competitiveness for NorTech, a Policy Bridge supporter. "These assets are invisible to those who are disconnected from them." Holifield said.

Measuring regional progress, deepening local programs for minority entrepreneurs, and promoting funding, technical, legal and marketing services were a few of Policy Bridge's many recommendations.

Participants and presenters also discussed forming a bridge between the technology sector and minority students in local STEM (science, technology, engineering and math) programs to help provide these future entrepreneurs with the tools they will need to help the region – and themselves – succeed.

Stay tuned: The community investment team will reconvene these local leaders in early 2013 to continue this important conversation.

Akron Community Foundation's board ratified grants totaling \$1.74 million during its quarterly meeting Friday, Nov. 30. It approved 30 discretionary, or board-determined, grants totaling \$408,000 for health and human services programs, particularly those that meet residents' basic needs.

A \$50,000 grant to the Akron-Canton Regional Foodbank will convene hunger relief and food policy agencies throughout the region in an effort to better serve the 240,000 Summit County residents facing food insecurity.

With hundreds of food pantries throughout Summit County, Akron Community Foundation's goal is to meet the hunger needs of residents where it is needed most. To do that, the community foundation is partnering with the food bank to build capacity and efficiency in areas of high need and promote best practices throughout the county.

By providing a flexible funding source and jointly examining the data, Akron Community Foundation can help meet the immediate needs of Summit County residents while also contributing to systemic

changes that will positively affect future generations.

In addition, a \$10,000 grant this quarter for the Respecting Options of Care Collaborative will improve end-of-life care by encouraging residents to communicate and record their wishes for future health care decisions before a crisis occurs.

Skip Radwany, medical director of Summa Health System's Palliative Care and Hospice Services, is a member of the community-wide collaborative of clergy, health professionals, hospitals and volunteers. He says such planning can prevent confusion and struggles among providers and family members.

"With advanced care planning, patients have confidence their wishes will be honored, and families have less stress and less complicated grief when faced with critical decisions," he said. "It also builds better relationships between families and health care providers."

## INITIATIVES

### **MILLENNIUM FUND FOR CHILDREN AWARDS \$48,000**

Local children's programs recently got a boost when the Millennium Fund for Children approved 34 grants totaling \$48,000. Grants will support arts, education, social service and health programs for Akron-area youth. This brings the fund's cumulative grant-making to \$498,909.

A partnership of the Akron Beacon Journal and the community foundation, the Millennium Fund for Children began in 1999 when local residents donated their last hour's pay of the millennium to create a permanent source of funding for local children's programs.

Since then, the fund has grown to nearly \$700,000 and funded beds for children in foster homes, live music and theater performances for students, food and clothing for at-risk infants, and much more.

#### GCEF GRANTS SUPPORT ANTI-VIOLENCE PROGRAMS

The Gay Community Endowment Fund recently awarded grants totaling \$26,900 to nine greater Akron nonprofit organizations.

Grants were awarded to programs that increase awareness about domestic violence and bullying in the LGBT community, including a \$2,400 grant to install KIDJAM! radio in Akron Public Schools.

Created by 91.3 The Summit, KIDJAM! promotes inclusion and respect among pre-teens through positive music and messaging. Other grants will provide outreach to LGBT individuals and their families in greater Akron, including
